Since Gordon's passing, Anne has continued the family's philanthropic efforts and recently made the decision to include CHKD in her will.

Putting family first

aming Children's Hospital of The King's Daughters as a beneficiary in your will is a simple way to enable the future of our important work. But maybe you've hesitated because you're unsure about how much to give.

Because life is unpredictable and the value of your assets is likely to rise and fall, you don't want to risk that someday your charitable gift could outweigh the well-being of your family.

Fortunately, there's a solution.

Percentage giving

Instead of a fixed amount, consider gifting a percentage of your estate or of specific assets. That way, gifts to loved ones and to organizations such as CHKD remain proportional—no matter how your estate fluctuates.

Here are three simple ways to put family first while supporting the area's most vulnerable children now and into the future:

- **1.** Gift a percentage of your estate to Children's Hospital of The King's Daughters in your will.
- Leave CHKD a percentage of your residual estate (the portion of your estate that remains after all gifts have been made and all claims of the estate are satisfied).
- **3.** Name CHKD as a beneficiary of a percentage of your life insurance policy or retirement account.
